




Meeting called to order by President Carl Chambers.

Officers Present: Clint Bryson, Bryce Chambers, Carl Chambers, Tom Dunham, Gene Ewing, Butch Finton, Harlan Nielson, Kent Robinson. Others in attendance: Carlene Barber, Shirley Blake, Marilyn Finton, Barb Robinson, Kimberly Stover.

2007 Officers meeting and annual meeting minutes were reviewed. Harlan moved, and Butch seconded motion to approve minutes. Motion carried.

Treasurer's report was presented by Kent. The year's finances were reviewed. It was noted our membership was down by 6 adult members and 3 juniors.

Committee Reports:

Trophy: Current trophy program was discussed. Spearfish American Legion donated \$150.00 toward the cost of junior trophies. A card of appreciation was sent with all officers signatures. After discussion Harlan moved, Bryce seconded, that Jr Cadets will from now on receive our regular state plaques instead of trophies. This will encourage them to start filling up their plaques. Motion carried.

Clothing: Inventory was reviewed. Discussion was held as to merchandising the clothing on hand. Recommended we use clothing as an award in all tournaments.

Jr Report: It was again noted that the Spearfish American Legion contributed \$150.00.

Hall of Fame: Both Clint Bryson and Gene Ewing asked to be relieved of their duties. The officers noted the fine job they had done over the years. Willard Waddle and Connie Filley volunteered and were appointed to be on the hall of fame committee.

Kyle Stover Memorial: Kimberly Stover reported 6 juniors, 13 and under turned in essays. No over 13 juniors submitted an essay. Therefore that \$50.00 award went back into the CD. The elected officers then reviewed and voted on their selection of the winning entry, to be announced at the annual meeting. Only an ID number, no names of those submitting essays is available during the judging.

League reports were given by various clubs. It was noted that league membership is down.

Election of Officers: Carlene Barbers name was the only one submitted for Secy-Treas. In 2009 1st Vice President's office will be up for re-election.

The 2008 tournament was discussed, and work assignments made. It was noted that all courts will be needed for the two shifts of singles pitching.

The 2009 tournament will be held in Pierre. There was discussion on how to handle more pitchers. The rules state that the tournament director will determine the schedule. The doubles tournament was discussed. Different formats were presented, with no recommendations made.

New Business: Butch reported that at the NHPA annual meeting they voted to increase the national dues from \$12.00 to \$17.00. Butch moved, Tom seconded, that we recommend to the membership to raise our dues to \$25.00 to cover this increase. Motion carried.

Discussion was held regarding the incentive local clubs would need to host a State Tournament, such as financial gain. The general consensus was beginning this year, to let them conduct the 50-50 drawings and other fund raisers.

Kent reported that he has not heard back from Steve Summerlin, the NHPA web master, in regard to SD having a link on their web page.

President Carl Chambers brought up the request from NHPA in regards to state charters helping to fund the new pitching courts used in the World Tournaments. There seemed to be no interest.

Clint mentioned that he had distributed to all the clubs an impressive banner sent out by the NHPA. He urged all the clubs to use them.

No further business appearing, Clint moved, Butch seconded to adjourn. Motion carried.

2008 SDHPA Annual Meeting Minutes August 30, 2008 Moose Lodge, Ft Pierre, SD

Meeting called to order by Pres. Carl Chambers. Carl recognized those who participated in this year's World Tournament and also those playing in their 1st State Tournament.

Butch Finton reported on the NHPA annual meeting in York, Pa and stated that national association will increase our dues by \$5. Previously \$12 was sent to NHPA for each card issued by SDHPA, now the amount will be \$17.

2007 minutes were read. Butch Finton moved, Bryce Chambers second, to approve as read. Motion carried.

Kent Robinson gave the treasurer's report. This year's membership is 102 adults, 17 juniors, with 14 new members signed up. Adult membership is down six from 2007.

Kurt Whaley moved, Donnley Elsen seconded, to approve treasurer's report. Motion carried.

Committee reports were then given:

Trophy: Kurt Whaley stated he thought we had enough new trophy plaques for next year's tournament.

Clothing: Kurt reported on the new logo for the clothing. Discussion was held on how to merchandise the clothing on hand.

Junior report: It was noted that the Spearfish American Legion donated \$150.00 to be used for junior trophies. This donation was from the efforts of Dave Bertch, horseshoe pitcher and past junior committee chairman. A thank you card was signed by all the officers and mailed to the Spearfish American Legion.

Kyle Stover Memorial: Kimberly Stover reported that the fund earned \$107.56 this past year. Kimberly reported, that six juniors age 13 and under submitted essays this year. No juniors over age 13 submitted an essay. Contributors to this Memorial fund are: Kyle Stover Memorial, Kent Robinson family, Bryce Chambers family, and Don Harmon family.

League Play: Reports were given in regards to league play around the state.

Election of officers: Office of Secy-Treas was up for election this year. Secy Kent Robinson reported that Carlene Barber's name was the only one submitted by the July 1st deadline. Kent moved, Tom Kester seconded, that a unanimous ballot be cast for Carlene. Motion carried. 2009 will have the office of 1st Vice President up for election.

2009 State Tournament was discussed. Should there be more singles entries than can pitch in two shifts on Sunday, the members recommended the Juniors play on Saturday along with doubles play.

Bids for the 2010 State Tournament were announced. Pierre and Sioux Falls both submitted bids. The Sioux Falls group stated that a letter from the city will be forthcoming as per our state policy. A vote was taken and Sioux Falls was declared the winner.

There was no old business. Under new business: The need for our state dues to be increased to cover the NHPA increase was discussed. Archie Filley moved, Butch Finton seconded, that we increase state dues to \$25.00. Motion carried unanimously.

Discussion was held regarding the doubles team format for 2009. Several formats were submitted by the officers.

1. Leave format as is, 2. Remove championship status, 3. Set percentage cap, 4. Draw for partners using a percentage basis. Butch Finton moved, Willard Waddle seconded, that we draw for partners with high-low percentage of top 12 entries being partners. Same for each group of entries submitted for each class. Motion carried on a split vote.

Kurt Whaley again brought up the clothing issue on how to handle sales. There was no consensus as to how we should handle it.

Following new business, Kent Robinson thanked the membership for his six years as secy-treas and the three prior years as president. He noted that the state has become financially sound. The state has cut down on trophy expense by establishing our permanent plaques. We have also added a money payout in addition to trophies. The clothing promotion program has been good and it's nice to see the state logo on clothing at tournaments. He noted that most of this promotion has been ideas and efforts of Kurt Whaley. Kent urged the group to work on expanding our membership, mostly by sanctioned play on many of the good courts around the state.

Roland Kleinschmidt moved, Ron Purkapile second, meeting adjourn. Motion carried.

Several awards were presented. President Carl Chambers recognized Ron Purkapile, Pierre for his extra efforts in working on the courts in preparation for tournaments. Kent Robinson had received NHPA patches for players who have been NHPA members for 20 years, or more. Those recognized were: 21 years: Tom Dunham, Jerry Jeffery. 22 years: Carl Chambers, Clair Harris, Kent Robinson. 23 years: Clint Bryson, Ed Osterkamp, Dave Zilverberg. 24 Years: Roland Kleinschmidt. 25 Years: Ed Gebhart. A 30 year patch was presented to Willard Waddle. The Kyle Stover Memorial award was presented to Macey Chambers. The Hall of Fame recipient was Leonard Roskam.


